Garbage & Recycling

Updated: 13th March 2025

OVERVIEW

This updated garbage & recycling policy aims to enhance community cleanliness and organization by providing clear guidelines for proper trash disposal. These rules help maintain property values, ensure a safe and pleasant environment, and prevent unnecessary nuisances such as pest infestations and unsightly waste buildup.

PURPOSE

The purpose of this garbage & recycling policy is to:

- 1. Ensure that trash and recycling bins are stored and placed properly.
- 2. Maintain the aesthetic appeal of the community by preventing prolonged curbside trash exposure.
- 3. Prevent damage to lawns, sidewalks, and common areas caused by improper bin placement.
- 4. Reduce rodent and pest problems by enforcing proper waste containment.

SCOPE

This policy applies to:

- 1. All residents, homeowners, and tenants of the community.
- 2. All trash and recycling bins placed for collection.
- 3. All waste disposal practices within the community.

POLICY

GARBAGE & RECYCLING RULES

- Proper Placement: Trash and recycling bins must be placed on the driveway or curbside, ensuring they
 do not block sidewalks or roadways.
- 2. **No Grass Placement**: Trash and recycling bins may not be placed on grassy areas, including front lawns and common spaces.
- 3. **Set Out Time**: Trash and recycling bins may be placed outside **no earlier than 6:00 PM the night before** collection day.
- Removal Time: All bins must be returned to their designated storage areas by 6:00 PM on the day of collection. Failure to remove bins in a timely manner may result in violations.
- 5. **Storage Location**: Bins must be stored against the garage door/home or out of sight on non-collection days, such as inside a garage, behind a fence, or in another approved location not visible from the street.
- 6. **Lid Closure**: Trash bins must always be properly closed to prevent waste from blowing into neighboring properties and streets.
- 7. **Bulk Item Disposal**: Residents must arrange for proper pickup of bulk waste items per county waste management guidelines. Leaving large waste items at the curb without prior approval is prohibited.
- 8. Pest Control: To reduce pests, food waste should be bagged securely before disposal in trash bins.
- Community Cleanliness: Residents are responsible for cleaning up any spilled trash or debris in front of their property.

ENFORCEMENT

- 1. **First Violation**: A warning will be issued.
- 2. **Subsequent Violations**: If violations continue, the HOA reserves the right to issue fines or take further action, including suspension of community privileges.
